Submit a change notification if:

- you do not accept a position in afternoon activities granted to your child
- the starting date of afternoon activities changes
- the need for hours of activities changes (the fee changes)
- the information on the recipient of the bill changes
- you terminate the afternoon activities. The period of notice is one calendar month. It is the most economical option to terminate the afternoon activities at the turn of the month.
